Statement to the Parliamentary Joint Standing Committee into Aboriginal and Torres Strait Islander Affairs (JSCATSIA), as part of the Inquiry into the Truth and Justice Commission Bill by Krauatungalung Elder, Uncle Robbie Thorpe 15th October 2024

For over two hundred fifty years this intentional Genocide against our humanity has been and continues to be committed by the British crown. In 1948, this heinous criminal act was identified as a peremptory legal norm of international law through the Convention for the Prevention and Punishment of the Crime of Genocide, yet it remains unaddressed, denied, avoided and hidden at all costs here in British colonial Australia seventy-six years later. It remains the basis of the racist illegal occupation, and it underpins everything that happens to First Peoples when it comes rights and justice. It's a vile and disgraceful situation that's been our lot since the beginning of colonialism here in 1770. The strayaliens, trespassers, invaders, colonizers are in breach of all things defined as genocide according to the 1948 Genocide Convention - colonial Australia still has never prevented or punished anyone for these crimes, they still have no consent or right to occupy our land or apply their laws, and have no treaties. "Australia" is an ongoing crime scene as a result - every time they make laws for us it is a continuing act that strips away our rights, it's systemic and well-practised, this crime. No matter what you do, you can't reconcile genocide, especially when the hostilities haven't ended, the Frontier Wars were never declared or ended, it's a continuing war crime scene as a result. Genocide crimes are not just about killing people with machine guns, bombs and machetes, there is lots more to it, including the subtle forms that are practised here these days in the land down under - outta sight, outta mind. It's too little, too late to be pretending the state and commonwealth here gives a damn, it's just been too long in the making and become normalised. It's totally insulting and extremely offensive not to have international legal scrutiny over this process; unbiased, impartial investigations into these heinous crime against our humanity. It's time to do the right thing, stop being complicit in perpetuating the misery it causes, and demonstrate to us now by establishing the "Australia" war crime trials, and let's see where the international legal community takes it from there. Stop the denial, evil reigns when good people do nothing. There's a parallel between genocide, ecocide, biocide and suicide. Don't leave it for our children, and don't disrespect our Ancestors, esteemed Elders this sacred land and everything on it. Genocide is a crime, "Australia" likes to hide behind the ignorant, racist, uneducated populations' opinions when it comes to our rights, they rely on this idea of democracy and their numbers to justify their existence here. The state pretends to be our benefactor, managing our welfare, "civilising" us, and their churches have played their role using god's name to Christianize us. Such evil. People don't understand the gravity, dimension and magnitude of crime scene Australia. We need international intervention now!! Justice delayed is justice denied.





The Treaty Assembly Address

'Taking It to The Next Level' by Krauatungalung Elder, Uncle Robbie Thorpe

There are many distinct tribal groups, nations, here on this continent, all with the right to self-determination and sovereignty. I want to pay my respects and honour all of them, support them, unite with them, and work with them on their justice issues such as land rights, treaties, restoration and restitution, and support their terms of reference and conditions on how this may be done. There can be no other honourable way, otherwise we are no better than the oppressors themselves. I believe we all must respect the bloodline Elders' law back to our countries, and this is represented by our Elders who sit in council. This is our land and our law, this has been the way which held our tribes and communities together for thousands of years, and we demand to have our customary law recognised and reinstated forthwith. We don't need some corporate body or colonial government appointed "authority", which is misrepresentative and unaccountable to our people. This is the problem, and responsible for the ever-widening gap, particularly over the last 40 years. Our Elders are the true representatives, spokespeople, law for country, so it's important to get that right before we go any further down the track with treaty business.

I believe it would be a good idea to have an official end of hostilities, and an ongoing, well-resourced education campaign backing it up. Our people, and all people surely, have had enough of the lies, fraud, corruption, and the entrenched, institutionalized criminality. We want justice, respect, and our fundamental rights recognised. It's been a long time struggling for this moment. We are tired of the bullshit, justice delayed is justice denied. There is no consent for colonial occupation. No treaty means no end of war, and that needs to happen to create a safe place to negotiate. Treaty can mean many things, a contract or agreement. Treaty creates the basis for co-existence and a new beginning. We want our peace restored, we owe it to our Ancestors, esteemed Elders, this sacred land, its inhabitants, and our children's children. Let's get it right, it's not about money or power, it's about our obligations to this place of which we are the rightful caretakers, guardians, and custodians.

If Treaty is done right, it can be a win-win. It will liberate us from the foreign control and domination which has seen destruction of the environment to the point of ecocide, which affects everyone. It has meant the theft of resources which end up offshore, and the



oppression of our peoples, including non-Aboriginal people in many instances. I believe very strongly in a proper and just treaty process, let's get it right. I'd like to thank the members of the Assembly for the great work that's already happened, but I want help raise the bar. It's the same for the Yoorrook Truth Commission, my proposal will empower the rightful custodians at the local, state, national, and international levels, giving them the status they are entitled to. It will also acknowledge the crimes against our humanity at a higher level than state-based colonial legislation which has failed us time and time again, which at this point has no consent, treaties or jurisdiction.

It's insulting and offensive in the extreme for the colonial state to be continuing to dictate the terms here, it's perpetuating the harm and the crimes. Time to take the treaty and truth business to another level, that being the international legal level. We deserve the unbiased, impartial scrutiny and standards that the international legal community have established. It will liberate us, and everyone else in the process. It's a brand new day, a new dawn, a much needed breath of fresh air. No more foreign invaders, multi-national mining companies, domination and control. We demand our independence from any form of foreign control, we never ceded our sovereign rights. Support us on this and keep the wealth and decision making here, it's a win if it done right, and it starts with booting the British crown out. The time has come.

Public Statement

by Krauatungalung Elder, Uncle Robbie Thorpe, regarding Genocide Prosecution of Mark Regev

9th October 2024 – Uncle Robbie Thorpe and Daniel Taylor are prosecuting Mark Regev (Benjamin Netanyahu's Senior Advisor for Foreign Affairs and Communication) in the Magistrates Court in Melbourne. Regev is being charged with Advocacy for Genocide, section 80.2D of the Australian Criminal Code, for public comments advocating for Genocide of the Palestinian people in the Australian Media.

"I find it offensive that this country that committed genocide against us is now allowing our country to be used as a base to advocate genocide against Palestinian people...How Australia responds to the Genocide Convention is important to me, considering it wasn't an offence until recently. Colonial Australia has failed to prevent genocide, and they have failed to punish anyone for these crimes here, or anywhere, despite the 1948 Genocide Convention. This is a significant case because it is engaging the act, and no person is immune – not the King, not the Prime Minister, Attorney Generals, nobody, not anybody is immune from being prosecuted on genocide charges. This case opens the door for Aboriginal genocide claims around this continent, and elsewhere around the world, for anybody.

Australia has been reluctant, unwilling and incapable of dealing with these issues. I hope this will allow people access to address these fundamental issues of international law, the crime of genocide and the most heinous crimes against humanity. You've got to stop genocide in your own back yard. No complicity, no contributing. If you've got gun running operations in your community, stop them...we don't want people running guns out of here killing people on the other side of the world. They're using this as a launchpad, a military outpost to do their dirty work. I know these illegal occupations here and in Palestine are guilty of these acts, there's no doubt about it. Our sovereignty, human and inherent rights are not up for foreign democratic decisions and voting. This is our land and law, just recognize that, stop the denial, unwind all the institutionalized racism, stop with the delusional notions of superiority.

Here, the deaths in custody continue, it's getting worse, the removal of children is getting worse, the conditions of life are getting worse, right across the board things are getting worse. The whole Convention for the Prevention and Punishment of the Crime of Genocide is in breach, every aspect, it's not just me saying it, reports from UN rapporteurs over many years, royal commissions, inquiries by the state itself all concur, it's out of control. The international community can't say they didn't know. It's such a clear example of genocide here and it's on a grand scale. No more excuses. Our lands are resource rich, there is much wealth and power here, our land is isolated and has become a safe haven of British colonial domination. We have a foreign head of state, we are not free or independent, we are stopped at every turn when it comes to self-determination, human rights, justice. It ends now, not when the invaders, trespassers, strayaaliens are ready. Now, today! We want our day in court, we want this illegal occupation brought to account.

Today is important, we as First People need to be able to utilise the Convention and ICCJ, it's critical. The Australian state has been unwilling and in denial. It's clear that British colonial Australia is reluctant, unwilling and incapable of addressing the issues, meanwhile we suffer. Colonial Australia has no consent to occupy our land, no treaties, obviously no jurisdiction for 254 years of the denial of our existence, laws, human rights has been our lot, we demand relief, justice, recognition, restoration and restitution for these ongoing crimes against our humanity. Enough is enough, this illegal occupation needs to be put in its place, the international legal community need to intervene. So much for "never again", we all know "evil reigns when good people do nothing". Where does the rest of the globe stand on all this? Who's complicit in the crimes here? This continent represents many independent, self-determining sovereign countries, we want our stories told, we want an authority that is unbiased, independent, impartial. These matters are and always have been extremely urgent, it's time to act!

We know there's a parallel between genocide, ecocide, suicide, and that affects everyone and everything. This unprovoked, undeclared, secret war and invasion needs to end now, and the international legal community need to step up. It starts right here, right now. Don't leave it for future generations, we all need to take responsibility for the future generations, our lands, cultures and environments. Time for an official end of hostilities. It's offensive and insulting to be talking now about state-based solutions, treaties, truth commissions. We want international scrutiny, we owe it to our ancestors, our esteemed elders, our sacred land, all that comes with that and our children's, children's children, everyone's children."

NOTICE OF COMPLICITY IN ABORIGINAL GENOCIDE¹

TO: CHARLES PHILIP ARTHUR GEORGE WINDSOR

TAKE NOTICE that **We First Peoples** of the continent that you invaders call Australia— and We call home and country and mother— will on [.....*insert date and time*.....] in the **INTERNATIONAL CRIMINAL COURT** at Oude Waalsdorperweg 10, 2597 AK Den Haag, Netherlands provide evidence in support of Our allegations that you are complicit in **the crime of Aboriginal genocide** and request that you be charged and prosecuted in the said court for the said crime.

CHARGES SOUGHT

The said Windsor, Head of State of the entity calling itself “the Commonwealth of Australia” (and that We refer to as “the Stolenwealth”), has since 2002 and continuing unless arrested **failed to prevent Aboriginal genocide** thus deliberately imposing conditions of life to destroy Us and causing Us serious mental and physical harm contrary to Article 5 of the court’s statute.

PARTICULARS OF CHARGES

Particulars of Windsor’s failure to prevent genocide include²:

- (i) failure to declare an **end to hostilities** against Us and an end to your multigenerational war against Us to steal Our Lands, Skies and Waters and usurp Our Law;
- (ii) failure to establish an internationally-supervised process of **truth-telling** about this war;
- (iii) failure to commence an internationally-supervised process of **negotiation for Our consent** (if any) to your occupation of Our Lands and other breaches of Our Law.
- (iv) failing to remove your deliberate impediments to Our prosecutions of you and your people for Aboriginal genocide such as the impediment that **only your Attorney-General can prosecute** genocide crimes.

CEASE AND DESIST LETTER

Re: Cease and Desist – Official Australia Day Flag Raising Event on January 26, 2025

I am writing to formally request that you immediately cease and desist from hosting the annual ‘Official Australia Day Flag Raising Ceremony’ event on January 26, 2025, known as Invasion Day. I also request that you cease and desist the raising of this terrorist “Australian” flag, and all other activities planned to occur during this event, including the Tri-Service Royal Guard of Honour, Australia Day Affirmation and National Anthem. Rather than host and participate in this offensive event, I invite you to instead attend the Dawn Service from 5am to pay your respects and learn the real history about the land you are on, in particular the crime scene that your ‘Government House’ is on.

It is extremely offensive to continue to raise this “Australian” flag, which features the Union Jack (the Butcher’s Apron), that represents terrorism to Aboriginal people. It represents your illegal colonial occupation. It is especially insulting and offensive to the true Sovereign Elders from the lands bordered by the illegal state of ‘Victoria’ that you are hosting this event just after the Day of Mourning Dawn Service at Camp Sovereignty, and that it will be hosted just several hundred meters from the Resting Place of the remains of 38 Ancestors from all the Sovereign Tribes of so-called “Victoria”, who were victims of genocide. If it wasn’t for acts of terror and genocide, ‘Victoria, the premier state’ – the first state to be constituted on the basis of the legal fiction of terra nullius - would not exist. You have no right to host this event, let alone be here, given there is:

- (i) No written agreement evidencing the consent of First Peoples to your occupancy.
- (ii) No written agreement evidencing the consent of First Peoples to your regime.
- (iii) Documented and undisputed evidence of your complicity in the genocide of First Peoples.
- (iv) Well-settled international law that you can not obtain land by genocidal invasion.
- (v) Any claims by you, your “king” aka Charles Windsor or your colony aka State of Victoria are invalid and void under your law and Our Law and international law by reason of your genocide against Us First Peoples — details in the attached Genocide Notice *CHARLES PHILIP ARTHUR GEORGE WINDSOR 13 Oct 2024*. Your case will be referred to the Office of the Prosecutor, International Criminal Court Oude Waalsdorperweg 10, 2597 AK The Hague Netherlands

If you do not Cease and Desist the above-mentioned activities, appropriate legal actions will be taken against you forthwith. This will be the only warning letter you will receive. Further, please refer to the Eviction Notice delivered to you (copy to your official secretary, the Premier and Attorney General on 19 October 2024). Please take this matter seriously and with the utmost importance. **Please confirm in writing by 7:00am Sunday 26 January 2025 that the event will not proceed.**

I, Uncle Robbie Thorpe, Truth-Teller Fire-Keeper and Elder, of Camp Sovereignty, "Kings Domain" near "Government House" and Shrine of Remembrance, affirm:

1. I am and was on 26 January 2025 the owner or occupier of this place or a person authorized by or on behalf of the owner or occupier thereof.

2. Pursuant to section 9 (1A) of the *Summary Offences Act* of the State of Victoria my above affirmation shall be evidence until the contrary is proved by or on behalf of the accused that I am and was the owner or occupier of that place or a person authorized by or on behalf of the owner or occupier thereof.

3. Pursuant to Rule 53.04(a)(b) and (c) of the *Supreme Court (General Civil Procedure) Rules 2015* of the State of Victoria I state

(a) My “interest in the land” is through my daughter Lisa and son Robbie Junior who are of the ancient original owners who came from the land and the land came from them. In any event under your own old “information of intrusion” as discussed by your High Court of Australia in the recent Yunipingu judgment earlier this month, I only need prove a better title that Margaret Gardner which is easy — I have my totems and my bloodline back to Country and I know the stories and Her Excellency does not have any of this.

(b) “The circumstances in which the land has been occupied without licence or consent and in which the claim for recovery of the land arises”: on 30 July 1768 a military officer was instructed in writing by the king of a small island in Europe to sail here and land here “with the consent of the natives” but no such consent has ever been sought or obtained and could not under Our Law be granted anyhow and the king’s kleptocratic family thus began and continued a genocidal war of military invasion against Us involving war crimes such as biological warfare in an attempt to steal and occupy Our Lands and usurp Our Law and to this day there is no document evidencing the end of those hostilities but it is widely-acknowledged that Our Sovereignty was never ceded;

(c) that I do not know the name of any person occupying the land who is not a defendant.

4. I refer to the bundle exhibit marked “URT 1” and the true copies of documents in the Exhibit:

(i) Eviction notice served by email on 14 October 2024. PAGES 7, 8 & 9.

(ii) Cease And Desist letter served by email on 25 January 2024 and in person on 26 January 2025. PAGES 11 - 15

(iii) Further correspondence in March 2025 from Governor Gardner (who disrespected Aboriginal Protocol by refusing to address me as “Uncle Robbie Thorpe”) and Premier Allan of the thieving entity calling itself “State of Victoria”. PAGES 19 - 21

(iv) Charge sheet and summons 28 March 2025 emailed to Senior Register MATT DALTON at Magistrates’ Court of Victoria accusing MARGARET ELAINE GARDNER of trespass offences contrary to section 9 of the said *Summary Offences Act*. PAGES

5. I refer to the usual defences to trespass charges and state that

- (i) there is **no factual dispute** as to the place and the property and its public and private nature;.
- (ii) there is no dispute about the **identity** of the trespasser;
- (iii) the trespasser had **no authority** under Our Law (the only Law applicable as there is no treaty or agreement with non-Aboriginal Peoples which would legitimise the attempted usurpation of Our Law);
- (iv) the trespasser has not made an **honest and reasonable** mistake of fact (... about genocide??);
- (v) the trespasser has no relevant **mental impairment** apart from the white denial and unearned white privilege endemic in you non-Aboriginal Peoples’
- (vi) there is **no necessity** for the trespass.

6. Under section 322K of your *Crimes Act* a person is entitled to use reasonable force to defend themselves or their property against an unlawful attack in Victoria. This includes defending property against a trespasser. A person acts in self-defence if they believe their actions are necessary

in self-defence and their actions are a reasonable response in the circumstances and they perceived them.

7. The history of your massacres of Our Peoples on Country shows Our Right of Self-Defence has never been recognised. We have come to your courts to use reasonable legal arguments to defend Ourselves and Our Land and Our Laws against unlawful attacks by "State of Victoria" officials and members. Will you even file and issue these proceedings?

The contents of this affidavit are true and correct and I make it knowing that a person making a false affidavit may be prosecuted for the offences of perjury.
